1. The Permittee shall keep the permit at the site of the burning operations conducted under the permit.
2. This permit is not valid for winds greater than 20 km per hour.
3. This permit is not valid from 2 hours after sunrise to 2 hours before sunset.
4. The amount to be burned at any one time shall not exceed 1 pile. 1 pile=1 cubic metre
5. All slash and land clearing debris shall be in piles or windrows, separated by a distance of at least 20 feet minimum.
6. The Permittee shall have at the location of the fire \_\_\_\_\_ adults and firefighting equipment In serviceable condition as follows:  
( ) Charged garden hose to burn site, ( ) Spade shovel, ( ) Rake, ( ) Two 5 gallon pails of water

I also hereby assume full responsibility for any damage caused directly or indirectly by and uncontrolled fire and I waive any claim against the Corporation of the Township of Joly and agree to save harmless the Corporation of the Township of Joly against all claims which may be brought as a result of damages caused by a fire permit pursuant to By Law 2011-04. I agree to pay the fee levied by the Fire & Emergency Service in connection with a violation of By-Law 2011-04 and/or the cost for extinguishment and out of control fire.
