A regular meeting of the Council of the Township of Joly was held on Tuesday, June 9, 2015 in Council Chambers.

The Public meeting was called to order at 5:30 pm.

Delegations:

Staff Sgt. Stacey Whalley, Almaguin Highlands OPP attended the meeting to provide his annual report. The detachment is continuing with the 2014 to 2016 Action Plan as previously presented. Staff Sgt. Whalley discussed the crime numbers in the area, emphasizing the need for individuals to secure personal property to prevent thefts. The detachment is currently fully staffed. Some officers from the Almaguin Detachment will be sent to assist with security at the upcoming Pan Am Games and to Northern Ontario this summer. Stats for the first quarter of 2015 were discussed and compared to the same period in 2014.
