

REGULAR MEETING MINUTES

January 12, 2016

A regular meeting of the Council of the Township of Joly was held on Tuesday, January 12, 2016 in Council Chambers.

Present: Mayor, Bruce Baker; Councillors: Betty Barnes, Budd Brown, Brian McCabe and Chris Nicholson.

Staff in attendance: Chris Fraser, By-law Enforcement Officer, Paul Frost, Road Superintendent and Leanne Crozier, Clerk Treasurer.

The Public meeting was called to order at 5:30 pm.

R2016-001

Therefore be it resolved that the Council for the Corporation of the Township of Joly approve the January 12th, 2016 Council agenda as amended to include:

1. Minutes of special meeting held December 23rd, 2015. **Carried**

Disclosure of Pecuniary Interest: Budd Brown – Accounts Payable – general nature thereof is payment to Brown's Quarry.

Delegations:

Don Roberts attended Council to discuss his hangor and on behalf of the hangor association at the Almaguin Highlands Air Park. Mr. Roberts provided Council with a history of the hangors and the airport going back to 2007, including discussions with the Mayors and Reeves in 2011 when the flying club offered to take over operation of the airport and the 2014 proposal submitted to the Air Park Committee from the hangor association. Mr. Roberts also discussed his own hangor which was built as a flagship hangor at a cost of \$ 168,000. Initially Mr. Roberts tried to promote the Air Park however as municipalities pulled out of the operation agreement he found this difficult. The installation of a septic at Mr. Robers hangor was briefly discussed and Mr. Roberts was advised that the resolution passed at the January 2014 Bi-Council meeting to allow this installation was defeated and as such, he did not have authorization. Mr. Roberts told Council that he does not care about the airport or its future, his focus is on his investment. Currently Mr. Roberts is storing 7 aircraft belonging to other people in his hangor in an attempt to regain on his investment. Mr. Roberts did suggest that if the Township of Joly wished to purchase his hangor, he would be willing to accept \$ 150,000.00. If the Township is not interested in purchasing Mr. Roberts hangor, all he requests is continued access to his hangor for the remainder of his lease, he indicated he would take care of snow removal. It was suggested to Mr. Roberts that he may wish to talk to the hanger owners and/or flying club to come with an offer for the airport and submit to Council for consideration.

Paul Frost, Road Superintendent attended Council and discussed the following:

- Work complete report no questions
- Proposed work 2 quotes were obtained for ice blades for the grader, order to be placed with Strongco; the pick up is scheduled to go for service and the Road Superintendent was directed to take to Griffiths; Council requested the loose gravel signs be taken down; training for the new employee was discussed; the Road Superintendent mentioned information received requiring the municipality to take over maintenance of railway crossings, he is to get more information; the Opiongo Trail road sign will be ordered; the signs are up at the Joly pit and the material has been removed as required, only item remaining is removal of the overburden which will be completed in the spring.
- The Road Superintendent was asked about items from the previous meeting weather reporting has been done but due to the loss of the part time equipment

operators cell phone a smart phone will be purchased which will enable weather monitoring as discussed; the beaver issue on Sand Hill Road continues to be an issue, and trapping of these nuisance beavers continues; health and safety and liability were discussed as some members of Council want to ensure proper due diligence is taken.

Chris Fraser, By-law Enforcement Officer attended Council to introduce himself. Chris Fraser provided Council with a brief overview of what he has accomplished in Joly and will be providing some reports for the February meeting for discussion and direction moving forward. Mr. Fraser is currently responsible for four municipalities and Joly agreed to have similar by-laws where possible for ease of enforcement.

Ministry of Agriculture, Food & Rural Affairs – Second Intake of the Building Canada Fund – Small Communities Fund (SCF) – notification that expression of interest submitted last year for a sand salt shed did not receive funding approval.

Staff Report – Fire Marque services – as discussed above – Council will ask any questions at the upcoming TRI Council meeting during the Fire Marque presentation.

Staff Report – South River Machar Fire Department Cost Recovery increase in rates – the minutes of the meeting attended were reviewed and the cost recovery increase. Council requested the new rates be included in the spring newsletter going out with the interim tax billing.

Staff Report – Joly road network & draft seasonal road by-law – Council reviewed and discussed the staff report and information attached. It was agreed that a special meeting be scheduled to discuss. Council also directed the Clerk to contact Tim Bryson to attend the special meeting as it appears he is using a seasonal road and an unopened road allowance without permission.
