

REGULAR MEETING MINUTES

February 14, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, February 14, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe; Councillor Chris Nicholson was absent; and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 1:00 pm.

R2017 - 015

Brian McCabe - Budd Brown

Therefore be it resolved that the Council for the Corporation of the Township of Joly approve the February 14, 2017 Council agenda as amended to include: MTO discussion. **Carried**

Delegations:

Al Nobes, Road Foreman attended to discuss and review the following:

- Ongoing snow removal
- Parts for the brake repair to the loader will be approximately \$1,250 plus labour plus tax
- Chocpaw and parking on the road was discussed
- Mr. Nobes thanked Council for his promotion to Road Foreman
- The Road Foreman indicated he requires more help on a regular basis
- Winging back of the snow banks and scarifying the roads were discussed the Road Foreman indicated the plow is wearing out and causing the rough roads due to its state – Councillor Brown will look into used snow plows and the Clerk will contact Freightliner for a cost estimate on a new truck for budgetary discussions
- MTO will be issuing a tender for road maintenance of unorganized townships adjacent to Joly Township. The Clerk was directed to contact MTO for information as Joly may be interested in submitting a tender when released
- At the recent Almaguin Road Supers meeting, common core training was discussed. The Road Foreman was directed to register for this training.
- When asked what other training is required, the Road Foreman indicated the only training he requires is gravel road school which is being held in Parry Sound on May 17th and 18th – he was directed to register for this training.
- A computer for the garage was requested and Council indicated they wanted ensure internet to the solar panel is provided at such time however these are to be included in the proposed budget and have approval prior to purchase
- The forks in the back yard are not included in any inventory lists which have been reviewed, does Council wish to sell. Council indicated they would discuss later
- The Road Foreman having a Restricted "A" licence with a "Z" endorsement was again discussed. The Road Foreman to have a Restricted "A" licence by the end of June 2017.
- Winter maintenance of Maple Ridge was discussed. It currently appears where the road is plowed is close to not being on the road. The Road Foreman was directed to clear this up and revert back to regular winter maintenance.
- Fuel consumption was discussed. The Clerk was directed to contact J Moore Petroleum to see about having pumps on tanks changed to enable fuel consumed per vehicle to be monitored going forward.
