Therefore be it resolved that the Council for the Township of Joly have reviewed the Almaguin Saving Huntsville Hospital meeting notes of November 25th, 2019.

And further, that the Council for the Township of Joly hereby supports the plan as presented with four (4) components as follows:

- The model would be based on assessment and not per household. Assessment would include all classes such as Industrial, Commercial, Recreational, Vacant, Seasonal and Permanent Residential, etc.
- 2. We would multiply the assessment by a "usage factor". The "usage factor" would be defined as what residents of a municipality use the Huntsville or Bracebridge Hospital compared to other hospitals in the region. Each Council will have to decide what their "usage factor" is. Residents close to Huntsville might be 100%, because they only use Huntsville or Bracebridge Hospitals, but those further away such as Joly might be 25%, because residents use the North Bay or Parry Sound hospitals 75% of the time.
- 3. We would approach MAHC and ask for certain services to be returned to Burk's Falls in return for our support of Huntsville and Bracebridge. One service we would like to see is a walk-in clinic in Burk's Falls.
