Whereas, reliable, high speed, affordable access to the Internet and e-connectivity is imperative the Township of Joly residents, businesses, non-profit organizations and visitors; and

Whereas, internet and e-connectivity are changing how humans interact with each other and with the world at large, as well as being a driving force for the current and future economy; and

Whereas, internet and e-connectivity create opportunity for increased innovation for consumers, businesses, agriculture, government, education, social and health development; and

Whereas, municipalities that prioritize and provide access to advanced internet infrastructure such as fibre, are surpassing those that do not in terms of social, economic, and knowledge development; and

Whereas, the Township of Joly must plan and prioritize for the deployment and adoption of this infrastructure including but not limited to pursuing collaborations and partnerships in the efforts to effectively achieve greater access to affordable high-speed internet throughout the region; and

Whereas, much of the Township of Joly does not have access to greater than 5Mbps internet service, which is well below the CRTC standard pf 50/10 Mbps; and

Whereas, the Municipal Council of the Township of Joly acknowledges that access to the internet and e-connectivity is a crucial part of our community mission to promote public safety, health, well-being and prosperity in order to improve the quality of life for present and future generations;

Therefore Be It Resolved that the Township of Joly supports Blue Sky Economic Growth Corporation's application to all government Broadband funding programs that will seek to provide funding to Spectrum Telecom Group Ltd to build a fibre and wireless access project in the region of Almaguin and North Parry Sound. Carried
