#### 5.1 Lake Bernard

WHEREAS Lake Bernard is a significant environmental, recreational, and economic resource for the Township of Joly and surrounding communities;

AND WHEREAS effective water level management is essential to preserving the ecological balance of the lake, protecting shoreline infrastructure, and ensuring the safety and satisfaction of lake users;

AND WHEREAS the Municipality recognizes the importance of cooperative engagement with the Ministry of Natural Resources (MNR) in the management of Lake Bernard's water levels,

AND WHEREAS the Province, upon request of the Municipality and the broader community, facilitated a public engagement to seek consultation from community stakeholders including the Municipality,

AND WHEREAS the public engagement led to collaborative conclusions between the Municipality and the Province about water level management on Lake Bernard which resulted in mutually agreeable changes to the approach to water level, most notably in regard to the seasonal placement and removal of logs at the outlet dam, as outlined in the District MNR's letter to the Mayor of Strong dated January 17th 2025 and including the January 2025 follow-up correspondence;

AND WHEREAS high water levels and premature replacement of logs in the dam before Lake Bernard is ice-free, or before the ice has deteriorated to a point where it no longer poses a risk, may result in unintended ice movement, shoreline damage, shoreline erosion and other adverse impacts on municipal infrastructure and private properties;

NOW THEREFORE BE IT RESOLVED THAT:

- The Council of the Township of Joly formally expresses its shared interest with the Ministry of Natural Resources and surrounding municipalities in the sustainable and responsible management of water levels on Lake Bernard.
- 2. The Municipality supports the modified approach to water level management as per the conclusions arrived at from the engagement, and of particular importance, supports the Ministry of Natural Resources refraining from replacing logs in the Lake Bernard dam until such time that the lake is fully ice-free or the remaining ice has deteriorated to a degree that it no longer presents a concern from the perspective of municipal risk and shoreline integrity.
- 3. A copy of this resolution be forwarded to the Ministry of Natural Resources and Forestry, the Lake Bernard Property Owners Association, and neighboring municipalities for their information and support.
