November 10, 2015

A regular meeting of the Council of the Township of Joly was held on Tuesday, November 10, 2015 in Council Chambers.

Max Webster attended the Council meeting to request an extension on the driveway culvert at 866 Forest Lake Road. When asked if Mr. Webster had a site plan for Council to review, Mr. Webster advised that Lee Webster had the information as requested but was unable to attend this meeting. Council requested Mr. Webster to attend the December meeting with all the information as requested.

October 23rd Comment form – Angelo Arra (under New Business on agenda) Angelo Arra was asked if he wished to address the comment form on the agenda. Mr. Arra requested clarification on receiving an invoice from Joly Township for the Sundridge Strong Fire Department attending his residence when an ambulance was called. Council explained the agreements with Sundridge Strong Fire Department and South River Machar Fire Departments outline an annual retainer to have fire protection and tiered response available to Joly Township which is paid for through annual taxation. The agreements with both fire departments also outline the fees for calls for service. The Township of Joly has passed a by-law to invoice these fees for service to the property owner for which the service is called.

Business Arising from the Minutes: R2015-157

WHEREAS the Ministry of Training, Colleges and Universities (MTCU) announced in May that it is ending the Ontario Self-Employment Benefit (OSEB) program; AND WHEREAS the OSEB program was designed to provide unemployed individuals who are or recently have been eligible for Employment Insurance with income and entrepreneurial support while learning to operate a small business;

AND WHEREAS the program has a 94% completion rate in Muskoka over the past 5 years and 76% of the businesses launched five years ago remain open, will above Industry Canada's reported 5-year survival rate for small businesses;

AND WHEREAS the 110 new businesses launched by OSEB graduates in Muskoka in the past 5 years sustain 142 jobs, demonstrating it is successful in giving participants a pathway to self-employment and is also an important rural economic development tool; AND WHEREAS OSEB programs from rural regions across Ontario have reported similar statistics:

AND WHEREAS MTCU's position that entrepreneurial support is available from other service providers overlooks the fact it has not replaced the essential income support component;

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the Township of Joly recognizes the value of the Ontario Self-Employment Benefit program to rural communities and requests the Ministry of Training, Colleges and Universities immediately reinstate the program until a formal evaluation – which must include input from delivery agencies and participants – is completed; and further that the Ministry ensure any changes to the OSEB program retain both the entrepreneurial and incomesupport components that have made is successful. **Carried**

Brennan's Road Bridge inspection update – After review of the October 14th and 27th inspection reports provided and discussion of site visit by Councillor Barnes and Councillor Brown, the Clerk was directed to notify Greer Galloway of the following outstanding issues:

- The erosion fix has not repaired the problem, rather is has relocated it to the end of the fix;
- There are still loose bolts on the left side of the bridge (travelling from the municipal office); and
- The remainder of the dry hydrant as already indicated.
