December 8, 2015

A regular meeting of the Council of the Township of Joly was held on Tuesday, December 8, 2015 in Council Chambers.

Paul Frost, Road Superintendent attended Council and discussed the following:

- Request for RAP to repair large culvert installation on 14 Hill Road
- Request for "How to monitor weather" to meet requirements the Road Superintendent was directed to try monitoring this from home as required and convenient and to also check with fellow Road Superintendents to find out how they meet these requirements.
- Monthly reports provided by Paul & staff report Council directed the Road Superintendent to provide one report per month covering work to be completed in the upcoming month. Work not completed in one month will need to be carried forward to the next month. Weekly reports as currently submitted for other purposes will be used to advise Council of work completed.
- The current beaver problem on Sandhill Road was discussed. The Road Superintendent is to determine who the adjacent property owner is to the culvert being blocked.
- Comment form received from Jeff McLaren was reviewed. The Road Superintendent will order a new sign with the proper spelling and the Clerk will respond indicating the sign is now located on the proper side of the road.
