

REGULAR MEETING MINUTES

April 12, 2016

A regular meeting of the Council of the Township of Joly was held on Tuesday, April 12, 2016 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe, Chris Nicholson; delegates, Judy Kleinhuis, Grant Thornton LLP, Luke Preston, Sunflower Festival; staff, Leanne Crozier, Clerk Treasurer and Paul Frost, Road Superintendent (arrived at 5:50 pm)

The Public Meeting was called to order at 5:34 pm.

Declaration of Pecuniary Interest: None

Delegations:

Judy Kleinhuis, Grant Thornton attended Council to present the 2015 financial statements to Council. Included in the agenda were three packages being, the Township of Joly Consolidated Financial Statement, the Almaguin Highlands Air Park Financial Statement and the Grant Thornton Report to Council – Communication of Audit Results all of which were reviewed in detail with Council. Management will provide a response to the identified control deficiencies as discussed with Council.

Luke Preston attended Council to request consideration of a financial contribution to the Sunflower Festival. This year the festival will be held on Saturday, August 6, 2016. Luke provided Council with an overview of the past festivals and some new features for this year. Although a financial statement was not provided, details of the financial position were discussed. The advertising and the entertainment for this event are the most expensive items in putting on an event such as this. The festival committee is looking for a \$ 1,000.00 contribution from each municipality. Luke thanked Council for their time.

Paul Frost, Road Superintendent attended Council to discuss the following:

- The comment form as received from Faye Crawford was reviewed and discussed. As this form refers to grading, the process of ensuring the road is wet prior to grading was emphasized to the Road Superintendent. Further, filling in pot holes with gravel does not fix potholes. Prior to calcium being added this year a deep grade is required.
- The proposed work report was reviewed. The part time equipment operator is now working Monday, Tuesday and Wednesday. The culvert issue on Lynch Lake Road was discussed with the Road Superintendent indicating the issue is a result of this culvert being on bedrock. Training the part time equipment operator was discussed. The Road Superintendent should be showing the new employee existing policies and procedures for operation of municipal equipment, with proper training being provided as well. Pictures of the forks purchased with the loader in 2014 have been taken. Chainsaw boots were purchased for the part time equipment operator, when asked, the Road Superintendent indicated the part time equipment operator does not have a licence to operate a chainsaw.
