

REGULAR MEETING MINUTES

May 10, 2016

A regular meeting of the Council of the Township of Joly was held on Tuesday, May 10, 2016 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe, and Chris Nicholson; delegates, Meaghan & Tyler Forde; Staff Sgt Stacey Whaley; staff, Leanne Crozier, Clerk Treasurer, Chris Fraser, Almaguin By-law Officer and Paul Frost, Road Superintendent (arrived at 5:50 pm).

The Public Meeting was called to order at 5:30 pm.

Delegations:

Meaghan and Tyler Forde attended Council to discuss Cedar Lane. The Forde's request Council to leave as is. The Clerk indicated the responses received have been provided to the municipal solicitor for consideration on how best to move forward. Council will review comments from the municipal solicitor and determine how best to move forward with this issue. At such time, all property owners will be advised.

Staff Sgt Whaley, Almaguin Highlands OPP attended Council to review stats and discuss policing in the area. The detachment currently has 20 constables including a full time analyst which enables focus patrols to deal with issues known in the area versus driving patrols looking for issues. Crime prevention was also discussed and the importance everyone ensuring their assets are secured. Council thanked Staff Sgt. Whaley for attending the meeting.

Chris Fraser, Almaguin By-law Officer attended Council to discuss sea cans and transport trailers. After a discussion Council directed the By-law Officer to prepare by-laws for use of these two containers as follows:

Sea cans will be permitted as follows:

- Unaltered sea cans will be permitted without a building permit or foundation;
- A maximum of two (2) sea cans per property will be permitted;
- All sea cans, existing and new must meet setback requirements as indicated in By-law 2008-06 being the general standards by-law; and
- Sea cans may be located on any lot including vacant lots without a primary use

Transport trailers will be permitted as follows:

- Existing unaltered trailers will be permitted to stay, however, they must meet setback requirements as indicated in By-law 2008-06 being the general standards by-law;
- Unaltered means in original state but may have wheels removed; and
- From passing of by-law forward, these trailers will no longer be permitted;

Paul Frost, Road Superintendent attended Council and discussed the following:

- Work complete no questions
- Work to do report The Road Superintendent went through the report in detail with Council. Council requested that while fixing the culvert at Barnes's driveway that Crawford's culvert into the barn be fixed as well as it is half full of sand and

was installed last year.

- The Road Superintendent also indicated he needs cutting edge for the loader and hopes budget will allow for this expense which should be approximately \$ 900.
- In discussion with Max Webster regarding trapping of beavers in the area of the large culvert on Sand Hill Road, the Road Superintendent indicated Mr. Webster has not been able to trap these nuisance beavers as he has not seen them.
- The comment form as received from Faye Crawford on April 12, 2016 was included in the agenda as incomplete due to the Road Superintendent not providing a response to be forwarded to Mrs. Crawford as discussed at the April meeting. Councillor Budd Brown indicated he had visited Mrs. Crawford to discuss her concerns and further provided the Road Superintendent with an appropriate response for the form. Councillor Betty Barnes indicated she has concerns with the volumes of dust at this corner and the potential for there to be an accident.
- The comment form as received from Tammy Dunn on April 20, 2016 regarding a hole in her driveway and the response from the Road Superintendent dated April 25, 2016, returned to the municipal office (and subsequently mailed response to Tammy Dunn on same day) April 26, 2016 was provided to Council.
- The 2009 letter of understanding between the Township of Joly and the Laurier Roads Board was discussed. As suggested in the staff report, the Clerk suggested the Road Superintendent meet with someone from Laurier to discuss a new agreement for the maintenance of Brennan's Road. Councillor Budd Brown suggested the Road Superintendent contact Keith Miller from MTO to determine who the Road Superintendent should initiate discussions with regarding this portion of the boundary road.
- A draft 2016 roads budget was briefly reviewed by Council. The Clerk clarified some of the proposed numbers. These numbers will be included in the general budget for review at a future meeting.
- Councillor Budd Brown left the Council chambers for the opening of the Quarried Granular A Tender 001-2016. This tender was put out for a quantity of material with the total cost not to exceed \$ 50,000 including HST. Two bids were received for this project as follows:
 - Brown;s Quarry Inc 3,341 tonnes
 - Fowler Construction Company Limited 2,652 tonnes

WHEREAS human trafficking is a heinous crime that has been referred to as modern day slavery; and

WHEREAS it is one of the fastest growing crimes that starts and stays in Canada, targeting victims – 90 percent of which are Canadian-born and predominantly female, averaging the age of 14; and

WHEREAS Ontario is a major hub of human trafficking in Canada, and victims are lured, manipulated and coerced, often over the internet from every part of Ontario; and WHEREAS human trafficking is in our neighbourhoods and our communities; THEREFORE BE IT resolved that the Council of the Township of Joly support Bill 158, Saving the Girl Next Door Act, 2016, support MPP Laurie Scott's motion for a multi-jurisdictional and coordinated task force of law enforcement agencies, Crown prosecutors, judges, victims' services and frontline agencies; and That a copy of this resolution be forwarded to all Members of Provincial Parliament and municipalities. **Carried**

Councillor Betty Barnes requested the Clerk forward this information to her via email.

Staff Reports:

Properties for sale in Joly Township was included in the agenda at the request of Councillor Brian McCabe. Mr. McCabe has been in discussions with a realtor and a new property owner in Joly Township regarding building a seasonal dwelling while the municipal office has advised the new owner the property he has purchased does not meet the general standards by-law to allow for a seasonal residence. The property owner should continue with discussion with the Clerk to work around this issue with an application for rezoning.

Recently, the Labour Affairs Office contacted the Joly Clerk to discuss the fact that aerodrome employee is subject to Federal not Provincial Labour regulations. As a result of this meeting, a new Sexual Harassment Policy and training for those involved will take place once by-law is passed.
