

REGULAR MEETING MINUTES

December 13, 2016

A regular meeting of the Council of the Township of Joly was held on Tuesday, December 13, 2016 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe, Chris Nicholson; delegations, John Newstead; and staff, Al Nobes, Road Department and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 5:30 pm.

Delegations:

John Newstead, Eastholme Representative attended the meeting to provide Council with an update. Eastholme is operating within its budget including some unscheduled repairs and a small increase is anticipated for 2017. There continues to be a waiting list and the facility is at full capacity. The transition in the Administration went well.

Al Nobes, Road Department attended to discuss and review the following:

- Comment form received from Sue Nichols has been addressed.
- Cleaning of the road culverts was started after the last meeting and many of the culverts required clearing, some had never been cleared.. Report included in Asset Management Plan is not accurate and will require updating.
- The beaver dam on River Road has been cleared by the property owner and the water is flowing.
- Snow plowing on Brennan's Road in the section where maintenance is shared, the road is sometimes plowed over the ditches. All was provided with a contact to discuss this matter and rectify this safety concern.
- Al indicated there will be approximately 30 new road signs required 2017. He will get an estimate for the budget.
- Snow removal of Maple Ridge was discussed.
- Budget to actual as of November 30, 2016 were reviewed. The cost of maintenance on Freightliner was briefly discussed, replacement of this truck needs to be considered.
- The Roads Committee was briefly discussed, it was decided to end this committee. In the event AI needs to contact Council he will start with calling the Mayor, if not available, he will contact a member of Council.
- The Clerk was directed to get clarification on the Key Performance Indicators provided for review and consideration by Eastern Infrastructure and bring back to a future meeting.
