### **REGULAR MEETING MINUTES**

May 9, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, May 9, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe and Chris Nicholson; and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 5:30 pm.

#### **Delegations:**

Al Nobes, Road Foreman attended to discuss and review the following:

- The comment forms have all been discussed, completed and addressed as received.
- The search for used parts for the loader repair have been unsuccessful and four wheel drive is needed new parts approximately \$ 5,000. The Treasurer was directed to increase the budget line item for the loader to \$ 10,000.
- All equipment has had an oil change and regular maintenance as required.
- Installation of culverts in driveways where there was previously no ditch was discussed. As a new ditch is being created at this time, Council directed the Road Foreman the driveway culverts required will be a township expense.
- The Part Time Equipment Operator position was discussed.
- Council emphasized the need to keep the pot holes in the surface treatment repaired on an ongoing basis.
- Council also discussed grading in the municipality and comment forms referring to the blade being in the air the Road Foreman may try a grading schedule.
- Council also discussed the material being placed on Peacock Road West as it will also be receiving an upgrade this season
- The Road Foreman was requested to pull material from the ditch onto the road surface and to determine the amount of material required to bring up Peacock East and to be stock piled in the yard for tendering purposes
- Every year material is placed in a wash out on Hill 14 Road and the material ends up in the ditch – the Road Foreman to check and consider pulling material from ditch.
- The park at Lynch Lake Beach was discussed and at this time, the fire pit will remain as is.
- The proposed budget for 2017 was briefly discussed. The Treasurer was directed to make some amendments and return.
