June 13, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, June 13, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown, Brian McCabe and Chris Nicholson; delegations: Judy Kleinhuis, Grant Thornton; Tim Bryson, Tom Bryson, and Robert Niemi; guests: Catharine Wright and Rick Huston; and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 5:30 pm.

Judy Kleinhuis, and Steve Luckett, Grant Thornton attended to present the draft consolidated financial statements for the year 2016. Mrs. Kleinhuis went through the documents and explained the differences between the financial statements and the in house budgeting process.

Mr. Tim Byson, Tom Bryson, and Robert Niemi attended Council to discuss Old Ranch Road. Mr. Bryson indicated Old Ranch Road is a colonization road and as such is an open road unless closed by the municipality. Township records do not reflect the same so Mr. Niemi indicated he would provide the necessary documentation for consideration of Council. Currently the Township seasonally maintains to Lot 4. At such time as Council is provided with the requested documentation, Council will review and determine how best to proceed with the interests of the municipality.

Mr. Bryson also asked Council if they would be receptive to a Joly Land Owners Corporation being developed to include those who want to remove snow from some of the Joly seasonal roads. If the Corporation provides the insurance coverage Council see no issue with this proposal.

Al Nobes, Road Foreman attended to discuss and review the following:

- Review of work complete eating periods and hours of work per day were discussed. The Road Foreman may alter his hours per day to more efficiently complete tasks without exceeding 40 hours a week.
- The 2017 CAR report has been completed and submitted
- Kents Mill Road bridge and the river blockage were discussed. The Road Foreman is to contact Oceans and Fisheries regarding permits if required. Replacement lumber for the deck of the bridge was also discussed.
- Quotes for the replacement of the box and plow/wing assembly were reviewed.
 The Road Foreman is to look into having the plow/wing repaired locally. The box replacement was approved.
- The staff report on Tenders was reviewed. Councillor Budd Brown left the

building for the discussion and direction regarding Quarried Granular products returning to the Council table after this discussion. The Road Foreman to provide the remainder of the necessary information to prepare and advertise the Tenders for 2017. Further review will be completed on the Winter Sand usage and volume required prior to issuing tender or request quote.

- The staff report on the Boat Launch at the end of Airport Road was discussed.
 The Road Foreman will finalize application for the driveway as submitted and work with the Airport Attendant to maintain this access on a seasonal basis.
 Sale of the Airport will result in all maintenance being done by the Road Department.
- The Comment Form as received from Mr. Cumming was reviewed. The Road Foreman indicated he has to change the culvert and is waiting until new employee is hired. He will complete form.
- The Road Budget was discussed. The Treasurer will make the changes as directed and include in draft overall budget for final consideration.
- Council asked when calcium would be applied to the roads this year. The Road Foreman indicated he had placed an order and is in the que for delivery. Priority roads were discussed and the Road Foreman will finalize prioritizing the roads.
