

REGULAR MEETING MINUTES

September 12, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, September 12, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes and Brian McCabe; Councillor Budd Brown arrived at 7:01 pm; and Councillor Chris Nicholson was absent; delegation: D S Whaley, Detachment Commander, Almaguin Highlands OPP; guests: Gil Chartrand, Catharine Wright and Rick Huston; and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 5:30 pm.

Therefore be it resolved that the Council for the Corporation of the Township of Joly approve the September 12, 2017 Council agenda as amended to include:

Delegations:

D S Whaley, Detachment Commander, Almaguin Highlands OPP attended Council to provide his annual report. The new action plan for the detachment is for 2017 to 2019 and will be distributed once finalized. There are not many changes from the previous action plan, the priorities remain the same with some changes to the strategies. Crimes in detachment area and Joly were reviewed and discussed.

Al Nobes, Road Foreman attended to discuss and review the following:

- Work completed including new gravel on Strong Joly Boundary Road and Peacock Road is complete; continuing with grading of municipal roads; the Equipment Operator attended common core training
- Comment Form P Dedels complete

 Comment Form H Mertins complete Council, upon reviewing photos of the area where the road washed out directed the Road Foreman to fix this area back to the condition prior to washout and the tree debris needs to be moved from where it was left as it blocked the access to this property. The Road Foreman indicated the ditching bucket was put on the backhoe last week.
- Roads budget to actual as of August 31, 2017 The Road Foreman was directed to purchase signs as per his approved budget.
- An update on Roads Committee was provided by the Road Foreman. The following items were discussed: brushing Lynch Lake Road North; rolling Peacock Road again; obtaining permission from R Stein re material to fix 14 Hill Road.
- Kents Mill Road ditching, bridge & water blockage the Road Foreman was directed to prepare a RFQ for removal of water blockage and replacement of decking on bridge. The Clerk to review RFQ prior to release.
- 14 Hill Road follow up from August meeting see above comment form from H Mertins
- The Road Foreman also advised Council that the Freightliner has gone in to GinCor for the box replacement. GinCor suggested due to the shape of the old box, they do not anticipate getting \$ 2,000 for it. Council directed the Road Foreman to arrange for the old box to be shipped to the Township yard and take off any usable parts.
- The bell line north of Brennan's Road bridge has finally been repaired and provides suitable clearance for all municipal equipment.
- The small washout of the edge of Forest Lake Road at the intersection with Strong Joly Boundary road was discussed. Council directed the Road Foreman to request this be fixed by Strong Township Road Department as it is on their portion of road. If it does not get fixed, the Road Foreman was directed to fix and Strong Township may be invoiced for this repair.
