REGULAR MEETING MINUTES

October 10, 2017

A regular meeting of the Council of the Township of Joly was held on Tuesday, October 10, 2017 in Council Chambers.

Present were Mayor Bruce Baker, Councillors Betty Barnes, Budd Brown Brian McCabe and Chris Nicholson; and staff, Al Nobes, Road Foreman and Leanne Crozier, Clerk Treasurer.

The Public Meeting was called to order at 5:30 pm.

Therefore be it resolved that the Council for the Corporation of the Township of Joly approve the October 10, 2017 Council agenda as presented. **Carried**

Delegations:

Al Nobes, Road Foreman attended to discuss and review the following:

- Work completed including removal of debris from water at Kents Mill bridge, material from ditching Paisley Rd in municipal yard, roads committee directed repair of ditching on Paisley Road due to safety concerns, a cylinder on the ditching bucket required repair at Near North Industrial
- Culverts were briefly discussed, two more have been located on both 14 Hill Road and Peacock Road – culverts need to be cleaned out
- Work To Be Done report as included in the agenda was discussed, ditching will be done on Paisley Road, Peacock Road, Maple Ridge Trail and Lynch Lake Road (seasonal portion) with work on seasonal road to be completed prior to October 15th. The Road Foreman indicated the material on the side of Old Ranch Road is to prevent water from washing road out in spring.
- Completing one project/job prior to starting another was discussed with the Road Foreman. Going forward the Road Foreman will complete on job before the next.
- The material from Westwind has been applied to Kents Mill Road.
- The Road Foreman indicated Mr. Stein has not provided approval as requested.
 Council directed the Clerk to forward a letter regarding this project to Mr. Milne and Mr. Magee.
- Road signage is being installed as time permits.
- The replacement of the deck on Kents Mill bridge is being discussed with Westwind.
- The winter sand will be completed this month as soon as arrangements can be confirmed.
- Parts for the loader are slowly coming in however some parts will not be available until December.
- Budget to actual for the Road Department was reviewed and discussed.
- The Road Foreman requested permission to purchase auto chains for the Freightliner. Council would like to see more information on the use of these prior to purchasing and directed the Roads Committee to review and discuss.
- As the Road Foreman will be on vacation the week of the Council meeting next month, Council requested he submit a Work To Be Done report prior to leaving on vacation.
